I have read, and am familiar with, diocesan policies pertaining to the expected behavior of Church leaders, both paid and volunteer, including:

- The Diocesan Child Abuse Policy;
- The Code of Ethical Standards for the Diocese of Salt Lake City; and
- The Safe Environment Program.

In light of these documents, I understand that I may be prohibited from serving as an employee or volunteer within the Diocese of Salt Lake City, if I have:

1. Been arrested for, or convicted of, any crime (including crimes of record which have been expunged and pleas of "no contest") involving child abuse, sexual abuse of a minor, physical abuse, causing a child's death, neglect of a child, murder, manslaughter, or felony assault against a minor;

2. Been found liable for civil penalties or damages in a proceeding alleging sexual, physical or verbal abuse;

3. Been subject to any court order involving sexual, physical or verbal abuse including, but not limited to, a restraining order in a civil case or a protective order;

4. Been subject to an administrative determination of child abuse or neglect;

5. Had parental rights terminated;

6. A history with another organization (volunteer, employment, etc) of complaints of sexual, physical or verbal abuse;

7. Resigned, been terminated or been asked to resign from a position, whether paid or unpaid, due to a complaint(s) of sexual, physical or verbal abuse;

8. A history of behavior that indicates I may be a danger to children within the Diocese of Salt Lake City. For example, driving under the influence may not be a disqualifying offense but a pattern of alcohol-related offenses may.
